**IN THE MATTER OF FAYIZ AL KANDARI DETAINED AT GUANTANAMO BAY DETENTION
CAMP SINCE 2002**

I write in respect of the above subject.

By way of introduction, my name is Lawyer Adel Abdul Hadi and I am the Managing Partner of Al Oula Law Firm (Adel Abdul Hadi & Partners) located in the State of Kuwait. I am a member of the defense team appointed to represent Fayiz Al Kandari, one of the two Kuwaiti detainees at Guantanamo Bay Detention Camp since 2002.

I have recently launched media campaigns calling for the release of Fayiz Al Kandari from Guantanamo Bay Detention Camp and his subsequent repatriation to Kuwait. An online petition which I addressed to The Honorable Barack H. Obama President of the United States, the US Secretary of State Sec. Hillary Clinton and you calling for Fayiz Al Kandari's immediate release received the support of over 15,500 people plus the support of 36 Kuwaiti Members of Parliament.
